Under the government’s Gift Aid scheme, WIS can claim 25% from HMRC on any donation made, as long as you are a UK tax payer, and have paid enough income or capital gains tax in the respective tax year. Individuals & Partnerships. for lower rate tax payers every £1 you donate, WIS can claim back 25p from HMRC.
